**Applications must be accompanied by a comprehensive description of products. Without this, applications will not be considered. Please do not fax photos. They must be mailed or e-mailed and must accompany the application form!**

The committee will give preference to hand-made art-related products which exhibit creativity and originality.

**The decision by the committee is final and no correspondence will be entered into.**

Food stalls must comply with the fire and health regulations of the local municipality.

**Health certificates must accompany the application.**

**Food stall holders are responsible for their own fire extinguishers as well as cooling equipment for perishable products.**

Food stalls are limited to the specific products granted and approved of by the committee.

#### PAYMENT

Successful applicants who have not yet paid, **must** pay the amount due into the Possies Supporters' Club (POK) account by **12 October 2018**. (**Details are on the application form**).

If you cancel after selection, a cancellation fee of 50% will be withheld. If the cancellation occurs after 12 October 2018, all fees will be forfeited.

## TRADING HOURS

**NO** vehicles will be allowed on the grounds during trading hours.

Exhibitors are welcome to stay open longer, but all exhibitions must be open until 21:00.

## ADMISSION TO GROUNDS

Exhibitors' vehicles will be allowed on to the grounds during the following times in order to prepare stalls.

To ensure the safety of pedestrians, all vehicles must be removed from the grounds by closing time.

Maximum 2 vehicles per stall will be admitted to the grounds.

Each vehicle will receive a sticker (2 stickers per stall). These must be affixed to the windscreen. Only these stickers will provide admission to the grounds.

Final clearance will take place after the festival on Sunday, 28 October 2018. The grounds must be vacated by 10:00.

If you need to be on the grounds before 25 October 2018, please make the necessary arrangements timeously.

One exhibitor and a helper will be allowed on to the grounds free of charge. **Additional helpers will have to pay an entrance fee of R100.00 per person per day.**

## 9. KOSSTALLETJIES

## FOOD STALLS

Food stalls will frequently be visited by a health inspector to ensure that the necessary standards are maintained.

If the stall does not comply with the standard, trading will be prohibited until the prescribed standards are met.

All food stalls MUST be in possession of the necessary competency certificate, which must be shown to the environmental health division during the Festival.

All waste must be placed in the large waste containers on the grounds.

Your stall must be neat and clean at all times.

**No fires or ash will be allowed on the ground or grass.**

**Stall owners will be fined if the regulations regarding fires on the ground and grass are ignored.**

**All ash in your braai drum / container must be removed before the stand is cleared.**

## 10. KRAGVOORSIENING

## 13. REGISTRASIE

Alle uitstallers moet vanaf 13:00 tot 19:00 op Donderdag, 25 Oktober 2018 en vanaf 06:00 tot 12:00 op Vrydag, 26 Oktober 2018 registreer.

Registrasie vind op die skole-sportterrein van Hoërskool Postmasburg (Ysterfees-feesterrein) plaas.

Uitstallers wat nie op hierdie dae registreer nie, verbeur hul fooie / stalletjies en die komitee sal dit herverhuur.

## ELECTRICITY SUPPLY

Electricity as well as overhead lighting will be provided.

Stall owners must please provide their own extension cords as well as extra lights.

**1 X 15 Ampere single phase**

**OR**

**1 x three phase connection is available per stall.**

**The use of gas will be preferable.**

Power points will be tested continually.

If the rules are disobeyed, the following steps will be taken :

1<sup>st</sup> offence : Warning, R500 fine

2<sup>nd</sup> offence : Eviction

## SECURITY

Postmasburg Ysterfees will provide full-time security, but cannot accept responsibility for any loss or damage. Stall owners will exhibit at their own risk.

## FORBIDDEN ARTICLES

The following articles are TOTALLY FORBIDDEN on the festival grounds :

- Laser lights
- BB guns
- Stink bomb
- Fireworks

The rules of a "flea market" must be respected.

Please respect other festival goers.

## REGISTRATION

All exhibitors must register on Thursday, 25 October 2018 between 13:00 and 19:00, or on Friday, 26 October 2018 between 06:00 and 12:00.

Registration will take place at the sports grounds of Postmasburg High School (Ysterfees festival grounds).

Exhibitors who do not register on these two days, will forfeit their fees / stalls and the committee will relet it.

Exhibitors are responsible for setting up / packing up of stalls, as well as chairs, tables, gazebos, etc. You only receive the allocated space.

Exhibitors are responsible for the neatness of their stalls, as well as the neatness of the terrain afterwards.

The committee cannot be held responsible for any loss, damage or injury. Security will be available throughout the festival.

Right of admission is reserved. If exhibitors are guilty of misconduct or transgression of the rules stipulated in this document, the committee has the right to expel such exhibitors, lay a R500 fine, or refuse admission to the grounds.

The committee does not accept any responsibility for violation of copyright nor for upholding concession rights between exhibitors.
